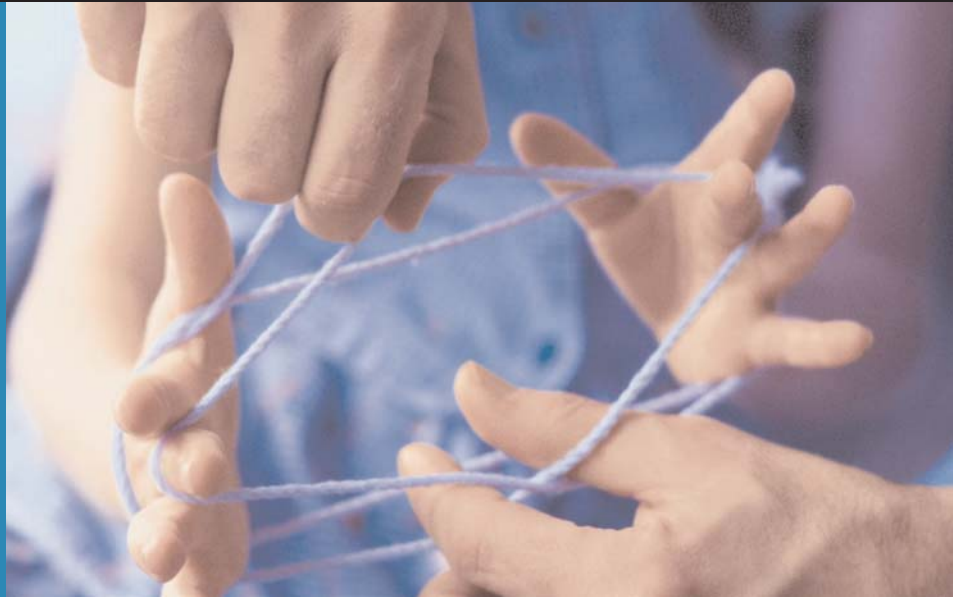

In most cases, your gift qualifies for maximum tax advantage under federal law.

They monitor all areas of community need—including human services, education, the environment, healthcare, the arts, and economic development. 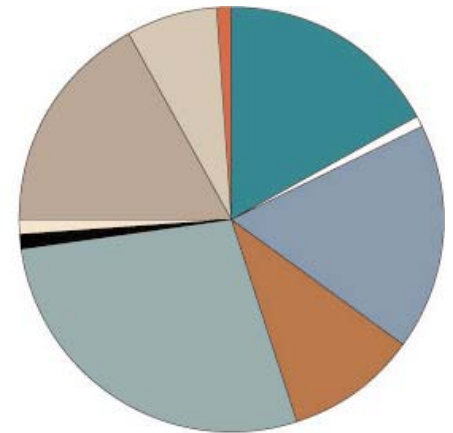
We are a **community leader**, convening agencies and coordinating resources to create positive change.
