



Letter from the **President and Chairwoman**

The Foundation believes that generosity has the power to unite and heal communities in good times and bad. A global threat like the COVID-19 pandemic affects more than just the infected. It is a time to come together to drive a spike of generosity, citizen engagement, business and philanthropy activation, and support for our community and nonprofits in Richland County.

We were built for this.

Community foundations are uniquely qualified to respond to the needs of a community. Strong relationships have allowed us to talk with leaders in the health and human services sector to better understand the local impact and how we can support not only emergent needs but also new opportunities that will emerge on the other side of the pandemic.

The Board of Trustees responded with the COVID-19 Rapid Response Initiative. They committed the 2020 Community Fund grantmaking budget for general support of nonprofits. Grants initially focused on providing basic human services to our most vulnerable citizens.

Our community investment staff worked with advisors of donor advised funds and other community funders to coordinate efforts to provide the broadest levels of support.

To further assist nonprofits with operational support, we launched a special COVID-19 Relief edition of the #RichlandGives platform along with an advertising campaign.

Equally important was our leadership role. Community foundations are led by diverse boards that provide a broad range of skills and unique perspectives of the area they serve. As such, community foundations are a trusted community convener in establishing important collaborations.

We don't know what lies ahead. But we want to be part of the solution.







Compassion In Action will continue to help in the community through a donor advised fund at the Richland County Foundation. After much thought and the advice of a consultant, Compassion In Action Board Members Nancy Labaki, Kristine Lindeman, and Bekah Beachy decided they could accomplish more in the community through a donor advised fund rather than operating as a nonprofit organization. They invested the financial resources from the nonprofit to focus on making grants to improve the quality of life for children with disabilities.

Compassion in Action's mission was to offer hope to families in our community experiencing medical crisis by providing assistance, guidance, and encouragement.

History of CIA

Compassion in Action was founded in 2012, when a group of community members organized a benefit for the family of Grant Reed, who was diagnosed with a brain tumor. After such a positive community response Compassion In Action was approached about hosting several more benefits for families in similar situations. The members of Compassion In Action began to recognize the financial strain that can result from having a child in the home with a serious illness or disability and became a 501C3 nonprofit. This allowed Compassion In Action the ability to financially reach more families. Through fundraising efforts and corporate sponsorships Compassion In Action financially assisted many families over the past few years, by covering expenses such as: rent, utilities, car payments, medical bills, medical equipment/supplies, and transportation expenses.

Patricia Maxwell **Scholarship Fund**

The Patricia Maxwell Scholarship Fund was established to award scholarships to Ontario High School graduates with learning disabilities to further their education at a trade school or college.

Patricia Maxwell taught students at Ontario Stingel Elementary School for 27 years. She created the primary learning disabled program for the school. Prior to Ontario, Pat taught in Lima.


She has provided a scholarship at Ontario High School for the past 28 years to a student on an individual education plan. She recently decided to move the scholarship fund from a private insurance company to the Foundation.

A gift from her mother's estate led to the establishment of the original scholarship. Her mother, Janette Nottingham, was

always interested in her daughter's students and would bring things in for them to experience. Once she brought a duck piñata from Mexico into the classroom which the students loved. Pat asked her mother to bring something more sedate on her next visit.

Her father, Fred Nottingham, owned Nottingham Automotive Group in Richmond, IN. Her brother, Michael, assumed ownership of the dealership. Michael facilitates a scholarship named after their father for graduating high school seniors in the Richmond, Indiana/Wayne County, Indiana area.







An Outdoorsman, Businessman, and Family Patriarch is Memorialized with a Fund

Patricia Adair, wife of Brian Arthur Adair, along with their children, Katherine Adair Truitt and Matthew Adair, established a donor advised fund as a way to memorialize him.

Brian passed away unexpectedly in February following a brief illness. An avid outdoorsman since his youth, Brian utilized this passion, as well as his business acumen when, in 1976, he opened Freedom Trails Outdoor Outfitters, a sporting goods store specializing in hiking, camping, backpacking, canoeing and Nordic skiing. Throughout his career, Brian had the opportunity to outfit campers and scouts, sharing his expertise with customers and helping them explore their interest in the outdoors. Brian retired and closed his store in November 2017 after 41 years of business.

Brian was involved in the Boy Scouts his entire life, achieving the rank of Eagle Scout with Troop #152. While in college, he was active with the Troop #152 Explorer Post. He continued his service to scouting with Troop #104, embarking on two

backpacking trips to Philmont Scout Ranch in New Mexico with his son, Matthew. At the time of his death he was a District Eagle Scout Counselor and was involved on the Troop Committee for #121.

Brian was a vibrant, fun-loving family man. He was an avid skier and traveled all over the United States, Canada, and Europe enjoying experiences on the mountains with his family. Brian was a wonderful husband, father, and grandfather to his four grandsons. According to his family, Brian was the consummate family man and patriarch to the Adair clan, keeping close ties among his siblings and their spouses, nieces and nephews, aunts, uncles and cousins.

Brian was a member of the First Congregational Church, where he was a former Deacon and Trustee in addition to being very active on other committees. He had the pleasure of being involved with the church camp, Hemlock Trails, since its inception in the mid-1960s, where he enjoyed volunteering his time to help maintain the property.

In the spirit of Brian's passion for the outdoors and scouting, the family plans to focus charitable donations in these areas.



Shelby Help Line Ministries serves the community with a Community Christmas Program and food boxes, clothing ministry, financial literacy, school supplies and clothes, medical equipment, free summer lunches for children and a community dinner.

The Michael and Tina Bennett Fund

Longtime Shelby residents Michael and Tina Bennett wanted to do something to give back and help their community. That was their motivation in establishing a donor designated fund to benefit Shelby Help Line Ministries at the Richland County Foundation.

"We have always been involved in the community and it's important to us to assist those who may need a helping hand," said Michael.

Tina said over the years, they helped with many projects at Shelby Help Line Ministries. Tina created financial spreadsheets and taught a financial literacy class. The couple volunteered with the Community Christmas Program and the Summer Lunch program.

"I liked being an officer and helping people. That was my life. This fund helps continue what Tina and I did professionally and personally," said Michael.

Michael served on the Richland County Foundation Board of Trustee from 2007 to 2016 and served as chairman from 2012-2014. He played an integral part to find a permanent home for the Foundation. During his tenure as chair, the Foundation purchased and renovated the historic William Ritter House. The Foundation moved to its new location at 181 South Main Street in 2015. Before then, the Foundation rented office space at various locations in Mansfield over a 70-year period.

"Michael helped lead the board to develop the Ritter House as the new home for the community foundation, creating a physical representation of the Richland County Foundation tag line For Good. For Ever," said Foundation President Brady Groves.



They hope to grow the fund significantly to contribute to the operations of RCDG.



Burnell-Evans Family Fund

Brigette Burnell and her husband, Scott Evans, like to include their children in the conversation about why giving is important.

The couple established the Burnell-Evans Family Fund and like the flexibility it offers to involve their children in charitable giving as they mature. Abraham is nine years old and Priscilla is seven years old.



Brigette said it provides them a mechanism to give to their church, Freedom Ridge in Ontario, as well as to other local charities.

Brigette serves on the Foundation Board of Trustees and the board at her church. Scott has volunteered at the Mansfield Area YMCA, Harmony House and Habitat for Humanity.

"Scott and I explain to our children that giving back can be done in several ways such as volunteering your time, making a donation or attending a performance at a nonprofit organization," said Brigette.

The family enjoys going to Kingwood Center Gardens, Mansfield Richland County Public Library, Little Buckeye Children's Museum, Gorman Nature Center, Mansfield Art Center, the Playhouse, and the Renaissance Theatre. They like to expose their children to different experiences and opportunities. "I appreciate the verification and documentation done by the staff at the Foundation to ensure that our gifts are used the way we intended," said Brigette.

Both are graduates of Ontario High School. Brigette is the Vice President, General Counsel and Corporate Secretary for The Gorman-Rupp Company and Scott owns and manages residential real estate properties.



EMPAC Continues to Deliver on its Mission

The Board of Trustees of EMPAC. Emergency Pregnancy Aid Contact, chose to establish a field of interest fund at the Foundation. The organization was founded by Richland County residents and for the 43 years of operation it was staffed by community volunteers. The fund is named for Betty Finlayson, one of the founders of EMPAC, Fran Conley, a longtime volunteer, and JoAnne Williams, a volunteer and the first director. EMPAC was organized in 1973 by a group of women at St. Peter's Church under the leadership of Margaret Walley.

The new fund will make grants for the purpose of providing support to parents, children and families emotionally and financially distressed by pregnancy.

EMPAC volunteer Peg Sipes said EMPAC recently ceased operations for a couple of reasons. "We were competing with organizations receiving federal funding and were duplicating services. On top of that, it was getting very difficult to recruit volunteers."

EMPAC volunteer Sheila Sipes Jones said EMPAC was there to help people and offer advice in a non-judgmental/ non-threatening way. Volunteers worked with clients to help them overcome their obstacles and frustrations related to pregnancy.

"The birth of a child should be a positive experience," said Sheila Sipes Jones.

EMPAC services were compassionate, caring and free to all families. Education on various topics included what to expect at childbirth, breast feeding, bottle feeding, shaken baby syndrome, parenting tips and financial counseling. The organization provided supplies such as layettes, cribs, pack n' plays, diapers and blankets.

The counseling and support evolved into peer-to-peer help as well as some clients then became EMPAC volunteers. "We want to give people an equal opportunity for a happy and healthy life," said Peg Sipes.



Sandy Mazur/Spherion Excellence in Leadership Scholarship

Beth DeLaney, franchise owner of Spherion Staffing, spearheaded the establishment of the Sandy Mazur/Spherion Excellence in Leadership Scholarship Fund.

Numerous franchise owners from across the country have contributed to the fund as a legacy to Mazur who was the Spherion division president, franchise and license, for 15 years, in Atlanta.

DeLaney said the franchise owners wanted to do something special to honor Sandy when she retired. "She was a blessing to all of us. We presented the new fund to her during an annual meeting in California," said DeLaney.

"We created a campaign to get others to donate. A committee has been formed to award a scholarship to a person who represents excellence in leadership."

DeLaney is very involved in the communities her office serves. She is on the Richland County Foundation Board of Trustees and serves as past chairwoman. She is a member of the Society for Human Resource Management and the Women's Business Enterprise National Council (WBENC). She also serves as an active board member of the Richland Community Development Group (RCDG) and the Ontario Growth Corporation.





The Rich History Alliance has a new fund at the Richland County Foundation. Rich History Alliance President Fred Boll said the purpose of the fund is to provide money for projects and programs to increase historical tourism and promote history for Rich History Alliance members in Richland County.

The seed money for the fund came from the Ohio History Connection Foundation. The State of Ohio collected a fine from the Rover Pipeline in 2017 because it demolished the historic Stoneman House near Leesville in Carroll County. Money was distributed to each county in the state for historic preservation. Richland County received \$60,000. The Rich History Alliance awarded a portion of the settlement in the form of 26 grants for historical tourism, education and capacity building.

The Rich History Alliance was formed in 2016 as a partnership of museums and historical sites. The mission is to collaborate to discover, preserve and share history in Richland County. Since its formation the alliance now hosts Rich History Weekend during the first weekend in May. It gives people a chance to explore historic sites and museums and learn about the county's past.

A Beloved Swim Coach is Remembered



Jim and Nancy Shoenfelt along with a group of family and friends established the Steve Shoenfelt Memorial Scholarship Fund. Steve was Jim and Nancy's son who passed away unexpectedly.

Steve's passion for swimming and people made him a truly great swim coach. He influenced many people in a positive way and helped many reach a potential they didn't realize they had.

According to his family, Steve had a huge appetite for life. You would find him in front row seats at a Bruce Springsteen concert, a dive bar listening to a new band, a week-long outdoor concert or watching a high school marching band performance. Food was also a passion; he would order the most unique item on the menu whether at a food truck or a five-star restaurant.

Two scholarships, in Steve's name, will be awarded by an independent committee each year. The criteria for the scholarships include a 2.8-grade point average, a minimum of three years as a high school swimmer and age group experience in USA or YMCA. The scholarship applicants will write an essay about their favorite band/concert or their favorite meal/food.

In 1986, Steve founded the Mansfield Waves Swim Team and coached about 150 kids each year. He also coached at Hudson High School, Dublin Community Center, Massillon Perry High School, Clear Fork Swim Club, and most recently head swim coach at Mansfield Senior High School. In the last few years of his life, Steve was dedicated to another passion - helping people cope with mental and emotional struggles. As a registered nurse in The Behavioral Unit at OhioHealth Hospital in Mansfield, Steve most favored his work with adolescents. He also had a way with words and understood the value of encouraging others, writing uplifting letters to family and friends.

Generous Donors Make Richland Gives a Success

Richland Gives, an online giving event hosted by the Foundation, raised \$316,049 for 92 Richland County nonprofit organizations. Since its inception in 2015, Richland Gives has raised \$1,041,049.

Richland Gives is designed to encourage people to contribute to local nonprofits they care about through a single giving website. The Foundation hosted the day

to build capacity, grow philanthropy and make the community stronger. It allows local organizations to raise funds and awareness as well as cultivate new donors and reinvigorate lapsed donors.

The Foundation awarded \$43,500 in grants as incentives during the giving event.





Third Street Family Health Services Invests in its Future

The Third Street Family Health Services established two funds with the Richland County Foundation to help it meet its long-term strategic goals. It will allow the organization to acquire additional capital for building projects.

TSFHS was originally known as the Third Street Community Clinic when it began in 1994. It is a private, nonprofit Federally Qualified Health Center with a mission to provide accessible, quality primary health care to the under-served. The services delivered by TSFHS staff include behavioral health, dental, medical and OB/GYN.

TSFHS believes that the health status of the underserved population can be improved

by providing accessible, affordable health care for those in need. People utilizing services at TSFHS have the right to be treated with dignity regardless of life circumstances. It supports people in their efforts to assume responsibility and actively participate in their health care plan.

TSFHS has several locations including its original one on Third Street in Mansfield. Other locations in Mansfield are Cornerstone OB/GYN, 770 Balgreen Drive and Mansfield Family Health, 270 Sterkel Blvd., along with Hawkins Medical Center, 2131 Park Avenue West, Ontario and Shelby Health and Wellness Center, 31 East Main Street, Shelby.

Mansfield Reformatory Preservation Society Inc. Fund

The Mansfield Reformatory Preservation Society wants to make sure the historical prison is around forever. That is why the Executive Director and the Board of Directors recently established an endowed fund to benefit the Mansfield Reformatory Preservation Society.

The Mansfield Reformatory, also known as the Ohio State Reformatory, was saved from the wrecking ball by a small group of local historical preservationists in 1994.

The Mansfield Reformatory Preservation Society is working to restore the facility to its original grandeur. Completed projects include the restoration of the Warden's quarters, the Central Guard Room, original stained-glass windows, replacement windows and a roof. Ongoing projects include the Ohio Correctional Museum now recognized and chartered by The Governor of Ohio and the newly installed Shawshank Museum. Future plans include the North Central Ohio Industrial Museum to be opened in 2020. All the current funding comes from donations, tours, paranormal tours, Halloween Haunted House, rentals of the facility and now this new endowed fund.

Today the Ohio State Reformatory Historic Site receives visitors from all over the world. Every year tourists, movie buffs, thrill seekers and paranormal investigators walk through the halls of this majestic structure.

The Women's Fund of the Richland County Foundation awarded its largest grant ever; \$25,000 to Richland County Youth and Family Council for a childcare initiative. The grant was announced during the annual grant award luncheon. The "Childcare Support for Step Up to Quality" grant will provide resources to local centers and in-home childcare providers so they can meet Ohio's new Step Up to Quality standards. The goal is to retain and grow available high-quality childcare in the community. Richland County Job and Family Services provided matching funds of \$25,000 for this initiative.

In its strategic plan, the Women's Fund has committed three years of investment in making quality childcare affordable and accessible to all women. They decided to focus on childcare following a community survey and focus groups.

In addition, she spent nine years as an advisory board member at the Ohio State University Mansfield. She also served on the Mansfield City School board of education.

She has led the downtown beautification project in Mansfield, volunteers at The New Store and is a literacy mentor at Hedges and Prospect Elementary Schools.

The award was named in honor of JoAnn Dutton, former executive director of the Mansfield YWCA. It celebrates and honors women who devote a significant amount of time and energy in a meaningful way to local charitable organizations.
