Opening Doors to a Stronger Richland County

By supporting a wide range of programs and projects from individual assistance to scholarships to community centers, we are working to make life better for everyone in Richland County. We want to make sure that when you walk out your door, you walk into a vibrant, growing, and strong community.



Thanks to the generosity of our donors, the Richland County Foundation awarded over \$8.8 million in grants during 2022.

This is the largest grant investment in the 77-year history of the Community Foundation. The investments support charitable organizations to strengthen our community. We leverage Richland Gives and the Osborne Meese Academy Capacity Building program to open doors for nonprofit organizations.

A few examples of how Foundation donors make life better for everyone can be seen in a pilot project with local police and social workers to help the homeless, a mobile mammography unit, a new behavioral health center for children, support for teachers and education, a new show arena for over 700 Richland County 4-H and FFA members, and improvements at local parks.

The Mansfield Rising Plan Committee invested in a new brand awareness advertising campaign, public art murals, and façade improvements. The Committee collaborated with the City of Mansfield to improve the city's main arteries.

Community support that spans a generation is visible through the Women's Fund Childcare Initiative with a goal to make quality and affordable childcare accessible to working families and a grant to the Area Agency on Aging's Ritters Run project to build affordable housing for senior citizens.

As the staff and board of trustees look ahead for emerging opportunities, we are mindful of the trust and commitment donors have demonstrated in wanting to open doors and build better lives through the Community Foundation.

Nonprofits Win During Richland Gives



Richland Gives, an online giving event hosted by the Foundation, raised \$507,069 via 1,802 donors for 96 Richland County nonprofit organizations. Since its inception in 2015, Richland Gives has raised \$2,476,007.

Richland Gives encourages people to contribute to local nonprofits they care about through a single giving website. The Foundation hosted the day to build capacity, grow philanthropy, and make the community stronger. It allows local organizations to raise funds and awareness as well as cultivate new donors and reinvigorate lapsed donors.

The Foundation awarded \$100,000 in grants as incentives during the giving event. The nonprofit organizations that had the most donors or raised the most dollars in the small, medium, and large nonprofit categories were awarded \$5,000 for first place, \$3,000 for second place, and \$1,000 for third place.

Mansfield Rising Update

The Richland County Foundation leadership took an unusual track to develop an investment strategy for downtown Mansfield in 2018. Instead of hiring a professional consulting firm, it had a citizen-led group create the plan.

The Foundation turned regular citizens into consultants which gives depth and authenticity to the plan. It provides a road map for projects and opportunities for partnerships to continue the renaissance of Mansfield.

The vision is for Mansfield to become an optimal place to conduct business, gather and live. This vision can be achieved through five key areas: effective land use, wayfinding, technical assistance for business, branding and marketing, and safety.

The Foundation allotted \$1.5 million to execute the Mansfield Rising Plan. To read the plan go to richlandcountyfoundation.org, click “Community Impact” then the “Mansfield Rising” tab.

Plan Progress

Branding

A committee collaborated with consulting firm, Medium Giant to create a brand and message for Mansfield and Richland County. The Richland Area Chamber and Economic Development and Destination Mansfield – Richland County have incorporated the brand into their marketing. The purpose of branding Mansfield and Richland County is to weave a powerful and positive story to raise awareness about why this is a wonderful place to live, play and conduct business. Beyond raising awareness outside the city limits, a brand and positive message could improve the story Mansfield residents recite about their city. Richland County organizations are invited to utilize the new brand. To access materials, go to brandrichland.com.

Public Art Project

The City of Mansfield in coordination with the Richland Community Development Group Art Sector created a Public Art Commission to vet projects. The “Luminous City” mural created by Braxton Daniels III, Robin Shoup Wilson and Luke Beekman is the first mural to receive matching funding from the Foundation. It was installed at Hursh Drugs on North Diamond Street. Another funded mural was the dragon on the side of the Buckeye Imagination Museum on Park Avenue West.

Free Outdoor Movies

The Renaissance Theatre, Mansfield-Richland County Public Library, Buckeye Imagination Museum, and Idea+Works collaborated to show outdoor movies on the plaza between The Ren and Theater 166. Many families attended and the collaboration seeks to continue this year.

Create Downtown Living Spaces

Two grant opportunities are available for downtown building owners to improve their property for residential use. The License Plate Tax has funded a Vertical Development Grant. It will help property owners bring buildings up to code. Many downtown buildings are unoccupied on the upper floors because the plumbing, electrical service, or stairs need an upgrade. The second grant opportunity is to create an incentive for downtown property owners to renovate the upper floors for apartments or condominiums.

OhioHealth committed \$100,000 to the Foundation for the Mansfield Rising: Downtown Investment project. The monies will be specifically used toward creating a permanent linear park, which will encourage pedestrians to walk between the Imagination District and the Carrousel District, which are less than a half mile apart.

Upgrade the City's Main Arteries

Mansfield City Council approved a design plan to improve Main Street. Construction should begin in 2025. The City of Mansfield received a federal grant for the project. You can see the application on Downtown Mansfield's website www.downtownmansfield.com/mainstreetimprovement.

It walks you through the history of Main Street as well as the future planning for the area. In total the project is over \$12M and will stretch from 5th Street to 1st Street.

The city converted Diamond Street to two-way traffic in 2021 and Mulberry Street in 2019. These changes create a more walkable downtown.

Free Public Wi-Fi

The Downtown Improvement Board (License Plate Tax Committee) approved funding for free public Wi-Fi from Central Park to the Carrousel District as the first phase. The Wi-Fi is strong and working well in the most high-traffic areas of downtown. The City of Mansfield IT Department will plan for additional phases. This is the first step towards a Smart City Plan.

Improve the Look of Businesses in Downtown

The Downtown Mansfield, Inc. Facade Improvement Fund received additional grant funding from the Foundation and Mansfield City Council via the License Plate Tax. Building owners received matching grants to make improvements. The grants assist economic development and the rehabilitation of historic properties in downtown Mansfield.

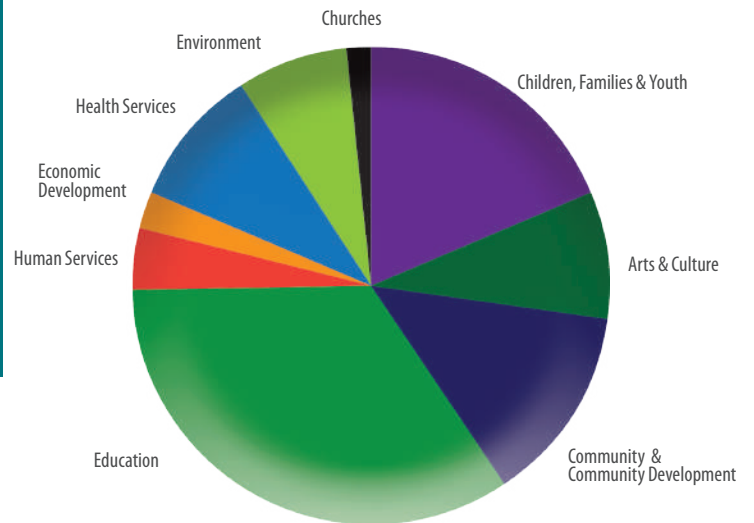

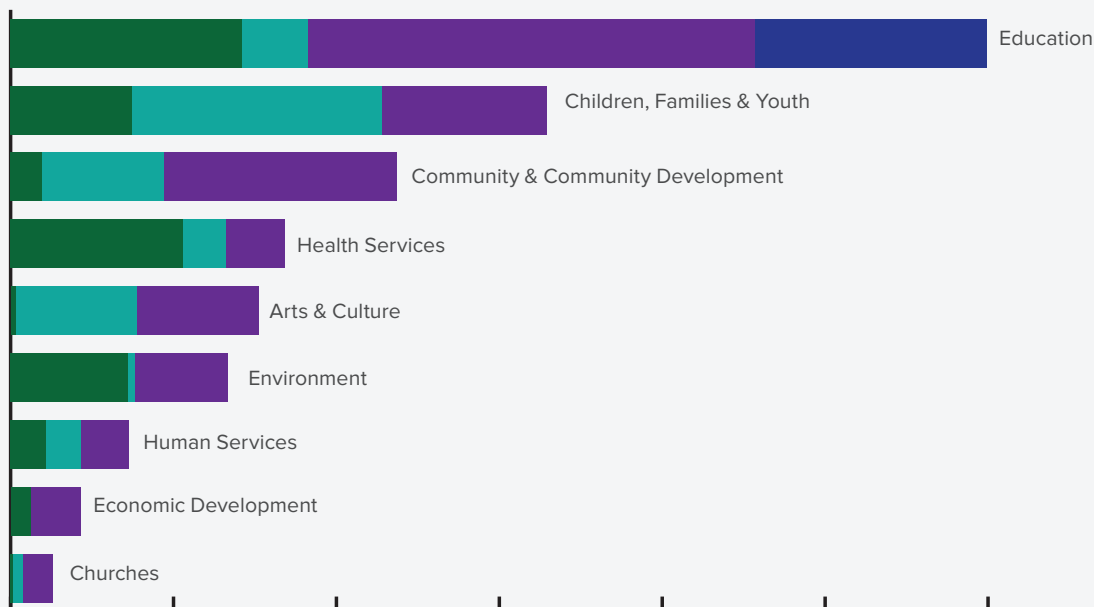

Opening doors to a stronger Richland County



The Richland County Foundation Gift of Grain Fund Committee held its inaugural meeting.

The Committee members are Brian Alt, farmer, Donnie Clark, owner of Elzy Milling and Trade, Jess Eilenfeld, Ohio Department of Agriculture Meat Inspector, Christy Keith, Richland County Fair Board member, and Adam Staley, Clear Fork High School vocational agriculture teacher and FFA Advisor.

A Gift of Grain Fund was established by the Board of Trustees to accept donations from area farmers and donors, and it provided an initial \$15,000 to seed the fund. The Committee will vet and award grants to agricultural nonprofit organizations.

Farmers looking to minimize their tax liability while contributing to their community can donate crops to the Foundation at a local grain elevator. Accounts are set up at Centerra Co-op in Mansfield and Sunrise Cooperative in Crestline. Additional elevators will be added as donation sites for the Gift of Grain Fund.

Farmers should consult with their tax advisor to determine whether a donation of commodities is appropriate to their tax situation.

Friends for Life



Jeff Ellington was a generous man who befriended everyone he met. So when Jeff died in 2020 after a lengthy battle with kidney cancer, a group of his friends decided to memorialize him by establishing the Jeff Ellington Legacy Fund through the Foundation. The purpose of the donor-advised fund is to continue Jeff's legacy of charitable giving.

"We were good buddies our entire lives," said Joel Staich, a founding member of the fund. "A core group of his close friends felt strongly about using Jeff's name to create a way to perpetually bless the organizations he cared about."

Jeff attended Mansfield Christian School and the Ohio State University. After returning to Mansfield, he co-founded Allegro Mortgage with

Staich, finishing his career as a much sought after mortgage professional.

"Jeff was well-known as an honorable and giving person," Staich said. "He went out of his way to put others' needs before his own, including donating to numerous charities."

One of Jeff's favorite charities was Hope for Hill Tribes, which is based in Columbus. Its mission is to help ethnic minorities in Thailand by providing academic, medical and financial assistance. Others include St Jude's Hospital for Children, the American Heart Association, Compassion International, Flying Horse Farm and Wounded Warriors. Jeff was also known for giving to individuals who were in need.

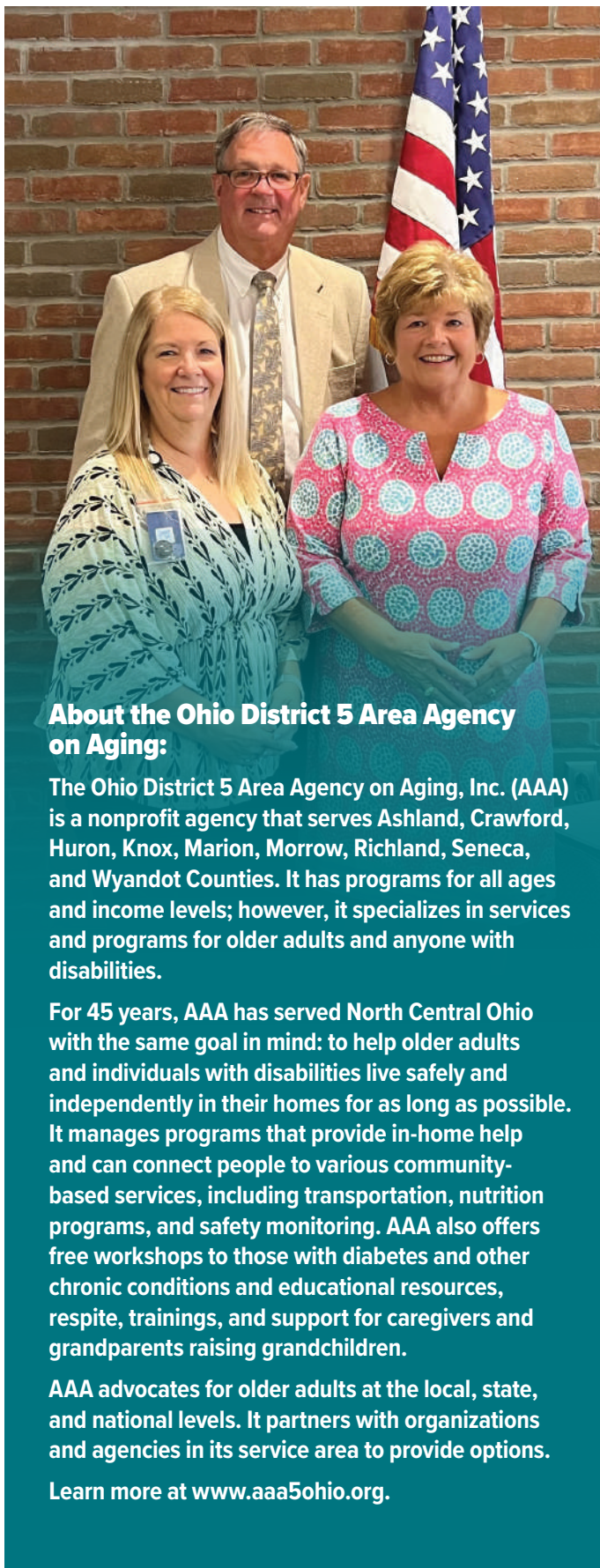
In addition to being a good friend, Jeff was also a loving husband and father. His wife Anne and their daughters Katie and Andrea will also serve on the fund committee.

About the Ohio District 5 Area Agency on Aging:

The Ohio District 5 Area Agency on Aging, Inc. (AAA) is a nonprofit agency that serves Ashland, Crawford, Huron, Knox, Marion, Morrow, Richland, Seneca, and Wyandot Counties. It has programs for all ages and income levels; however, it specializes in services and programs for older adults and anyone with disabilities.

For 45 years, AAA has served North Central Ohio with the same goal in mind: to help older adults and individuals with disabilities live safely and independently in their homes for as long as possible. It manages programs that provide in-home help and can connect people to various community-based services, including transportation, nutrition programs, and safety monitoring. AAA also offers free workshops to those with diabetes and other chronic conditions and educational resources, respite, trainings, and support for caregivers and grandparents raising grandchildren.

AAA advocates for older adults at the local, state, and national levels. It partners with organizations and agencies in its service area to provide options.

New Area Agency on Aging fund catalyst for giving



Jana and Pat Mulherin provided a pathway for people to donate to the Area Agency on Aging Ohio District 5. They awarded a grant from their donor-advised fund to the Area Agency on Aging to establish an agency endowed fund.

“Our philanthropic philosophy is simple; it is about giving back. The endowment fund will be a way for people to donate to the Area Agency on Aging and it will make a difference in our community,” said Jana Mulherin.

“We give because we believe in the organization, its mission, and employees. The fund is important so that other people in the community realize they can do this as well. Either set up a fund for a nonprofit or give to an existing fund at the Foundation,” said Jana Mulherin.

Pat Mulherin’s grandparents, John and Winnie Mulherin, relocated from Iowa to build their Dairy Queen in Mansfield at the corner of Glessner Avenue and Wood Street in 1948. Later, another DQ store was opened on Ashland Road by the family.

“The community embraced the Mulherin Family then and our family continues to embrace the community with nonprofit involvement. We feel a responsibility to give back,” said Pat Mulherin.

To incentivize donors and grow the fund, the Mulherins matched all gifts to the fund in 2022.

Area Agency on Aging Ohio District 5 CEO Duana Patton said the fund will be a catalyst for future gifts.

“This agency endowed fund is such an honor. Jana and Pat are great advocates for our work. This honors Jana’s work on our board over the past seven years,” said Patton.

Patton wants to help the fund grow.

Renaissance Performing Arts Endowment Fund



With a focus on long term financial goals, the Renaissance Performing Arts established an agency endowed fund at the Foundation.

“The new fund enhances stability and sustainability for the Renaissance Theatre. It will diversify our funding and give donors an additional option for gifts that can benefit The Ren for many years to come,” said Renaissance Performing Arts President & CEO Chelsie Thompson.

“We trust the Foundation and its investment strategy. It has a heart for the nonprofit community and we know that donors who choose to make a gift to the fund will have peace of mind that their funds are always put to good use.”

Every donor has a different priority, some like supporting operations and others like an investment option that lasts into perpetuity.

During COVID, the Renaissance Theatre was shut down for a combined nine months of the pandemic. When it reopened, it was only able to offer limited seating at a 25-50% capacity for over a year.

“We had to find ways to bring in revenue. The staff is highly creative, and they delivered on our mission,” said Thompson.

Thompson said the Renaissance has a big opportunity now that the Imagination District has been formed in partnership with the Buckeye Imagination Museum.

“We have built a number of high-quality programs. One of our main goals moving forward is to go outside of our walls and improve our community engagement to make sure all people have access to those programs,” said Thompson.

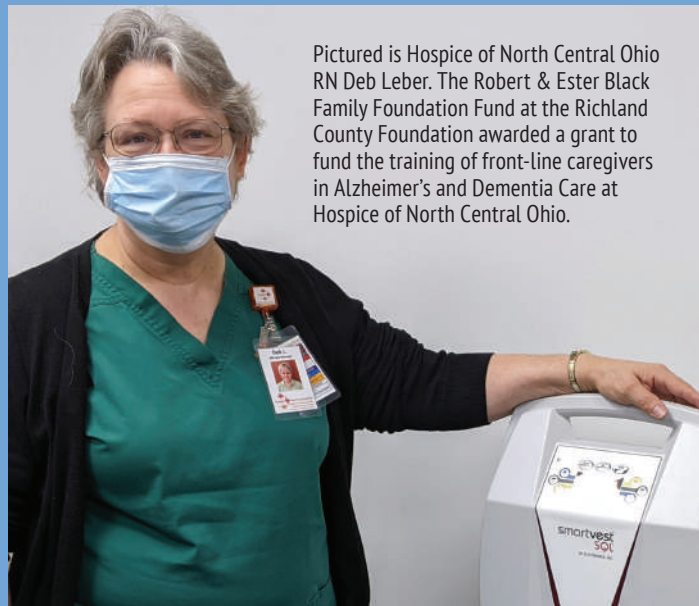

You can make a gift of cash, stocks, bonds, marketable assets, or a transfer from your IRA. Your charitable gift qualifies for the maximum tax advantage available by law.

Gifts from an IRA

Individuals aged 70 ½ and older can transfer up to \$100,000 annually from an Individual Retirement Account (IRA) to a charity without being federally taxed.

This law is important to local charities operating as agents of philanthropy in order to continue to build community and improve social service programs that benefit people every day.

A provision in federal law allows for transferring IRA assets directly to charity otherwise known as a qualified charitable distribution. By going directly to a qualified public charity such as the Richland County Foundation, the money is not included in the IRA owner's income and—most important—is not taxed, preserving the full amount for charitable purposes.

The Richland County Foundation can help donors execute the transfers and choose from several charitable fund options for their gifts. IRA transfer gifts of any amount can be made to an existing fund at the Foundation or for the establishment of a new fund.

If you would like to establish a new fund, the types of funds that qualify for the tax-free IRA transfers include:

- Unrestricted Fund
- Field of Interest Fund
- Designated Fund
- Scholarship Fund

*Donor Advised Funds do not qualify for tax-free IRA transfers

The minimum amount to set up most funds is \$10,000, except for a scholarship fund that has a minimum of \$20,000.

Charitable Gift Annuities

A Charitable Gift Annuity allows you to make a gift to the community while at the same time providing you with a guaranteed income stream. It is an ideal plan for those who would like to make a significant gift during their lifetime but depend on the income from their assets.



Charitable Lead Trust

You can place cash or property into a trust that pays a fixed amount to your community foundation for the number of years you select. Once this period ends, the assets held by the trust are transferred to the beneficiaries you name. In some cases, you receive a substantial reduction in federal gift and estate taxes.



Tools for Planned Giving

You can add to your fund at the Foundation – or even establish new funds – later as a component of your estate planning. Those gifts might include assets such as cash, bonds, IRAs, realized insurance policies, appreciated stock, and income-producing tools like charitable gift annuities.

Your assets will flow directly into the charitable funds you designate.

Gift in Your Will

When you make plans for a gift to the Foundation in your will let us know so you can become a member of the Legacy Society. A bequest to Richland County Foundation can be easily made through a simple designation in a will or trust to establish a fund or add to an existing fund. You may also establish a fund in your name that will go into effect after your lifetime.



Charitable Gift IRAs or Retirement Plans

If you plan to make a charitable bequest, a retirement plan is one of the best types of assets to transfer to a charity because it produces taxable income. Most assets that an heir inherits are free from income tax. However, an heir will pay income tax on disbursements from a decedent's retirement plan such as a profit-sharing plan, Section 401(k) plan, or IRA. If you are going to make a charitable request, it is usually better to transfer the taxable assets subject to income tax to a tax-

exempt charity — such as Richland County Foundation — and to transfer the non-taxable assets not subject to income tax to heirs.



Charitable Remainder Trust

You can place cash or property in a trust that pays an annual income to you (or another named beneficiary) for life. After your death, the remainder of the trust transfers to your community foundation and is placed into a charitable fund you have selected. You receive income tax benefits the year you establish your trust.



Life Insurance Beneficiary

Life insurance provides a simple way for you to give a significant gift to charity, with tax benefits that you can enjoy during your lifetime. By naming the Foundation as beneficiary, you retain ownership of the policy and have access to the cash value as well as the right to change the beneficiary. This type of contribution allows you to give to your favorite charity after you die, even if you don't have the liquid assets right now. While

you retain ownership of the policy, there is no charitable deduction for the value of the policy when you designate the Foundation as the beneficiary or for subsequent insurance premiums. However, any proceeds payable to the Foundation at your death will not be subject to federal estate taxes.



Join the Legacy Society

The Legacy Society provides a way for the Foundation to recognize generous individuals who have included the Foundation in their estate plan. Those donors understand that a planned gift is a simple way to contribute to the future of our community, and in some cases, to create a favorable tax situation. Women's Fund Awards Grants



The Women's Fund of the Richland County Foundation held its annual luncheon and awarded over \$40,000 in grants and announced the JoAnn Dutton Award honoree.

For the fourth year in a row, the WF granted \$25,000 to Richland County Youth and Family Council for the childcare initiative. RCYFC has matched the \$25,000 each year of this project. In its strategic plan, the Women's Fund is committed to making quality childcare affordable and accessible to all women.

This year, the Childcare Committee led by RCYFC, will plan a conference to provide continuing education credits to childcare employees. It also will focus on mentoring in-home providers and give grants for additional resources at daycare centers.



Other grants were award to: Buckeye Imagination Museum for a girl's art camp, Mansfield City Schools for a girl's mentoring program, North End Community Improvement Collaborative for a girl's mentoring program, North Central State College Foundation for student childcare scholarships, and YMCA of North Central Ohio for a female self-defense class.

Since 1998, the WF has awarded \$524,000 through 318 grants impacting hundreds of lives.

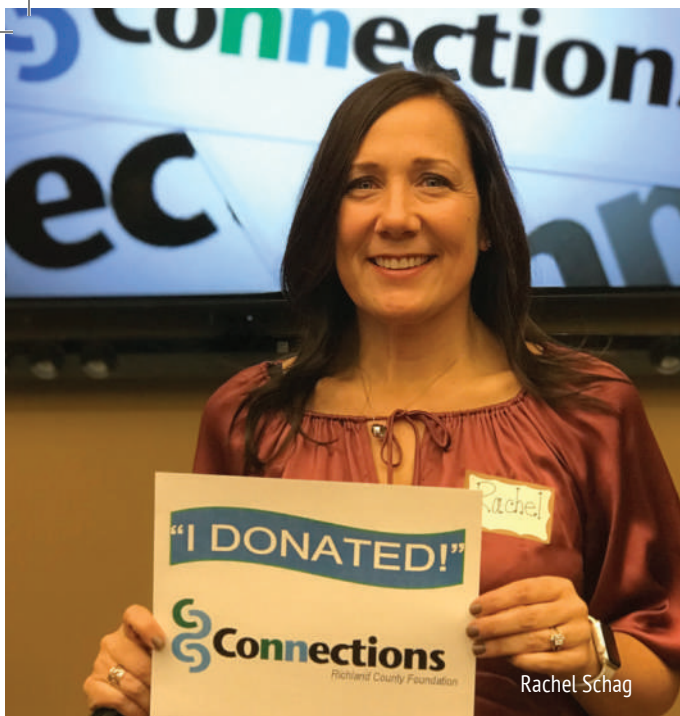

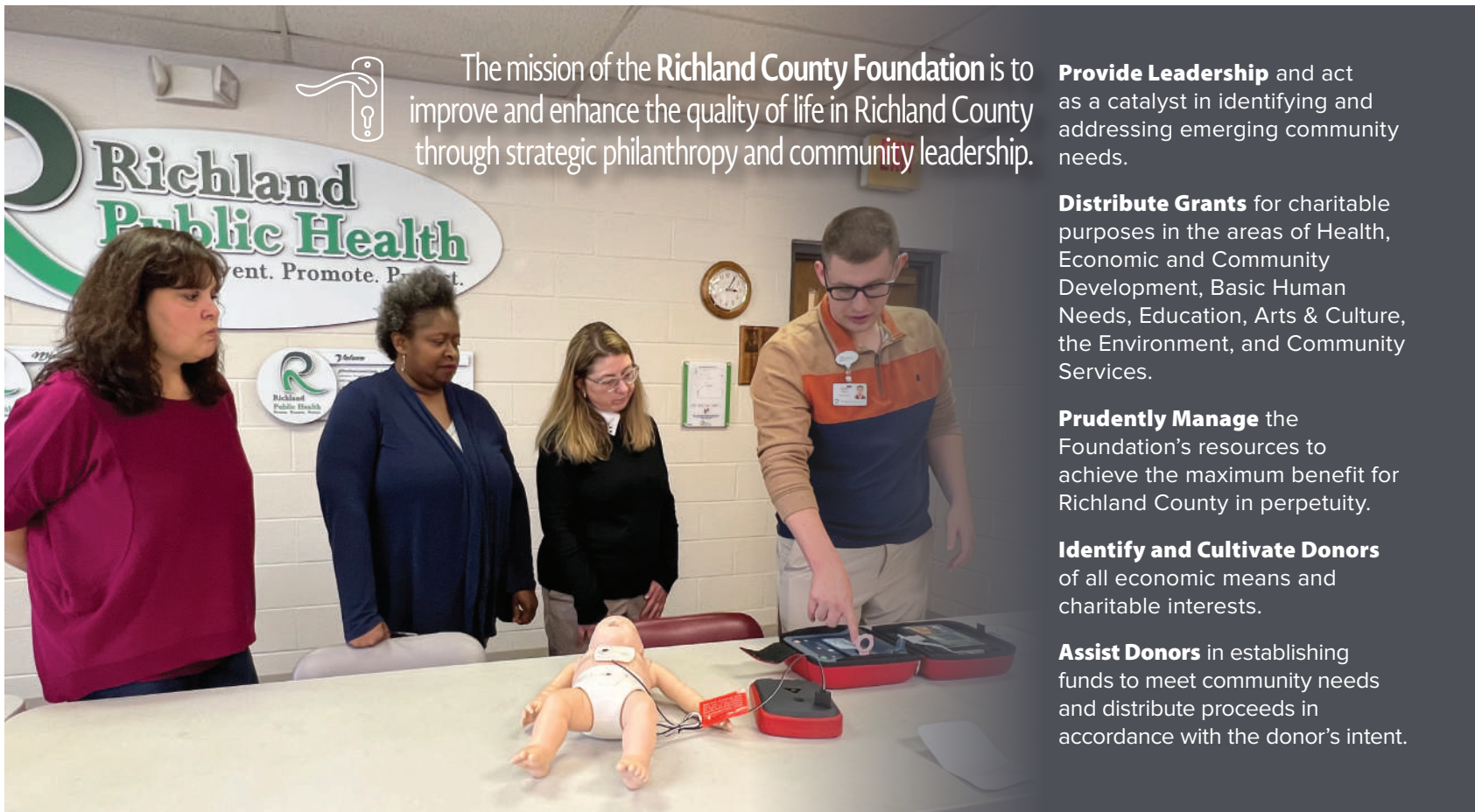
